Required Criminal Records Disclosure: the existence of a criminal record does not automatically disqualify you for employment consideration, unless it is a conviction for an enumerated crime (see attached). However, it is important that Distinctive Schools know your complete criminal history to properly evaluate your application. You must disclose it in full. Failure to disclose each conviction may result in disqualification of your application or termination of employment.

Convictions include all felony or misdemeanor convictions, weather by pleas of guilty, nolo contendere or no contest or after bench or jury trial. Convictions that result in sentences of probation, conditional discharge or imprisonment must be reported. Convictions of driving while intoxicated or under the influence (DUI), and driving on a revoked or suspended license must be reported. But, convictions that resulted in sentences of supervision in Illinois or traffic offences other than DUI or driving on a revoked or suspended license should not be reported (i.e. speeding tickets, running a red light or stop sign, driving without insurance, etc). Finally, you are not obligated to disclose sealed or expunged records of conviction or arrest.
